No.F2(30) Fix (TRE)/200506; In exercise of the powers conferred by section 74 of the Indian Stamp Act, 1899 (2 of 1899) read with the Government of India, Ministry of Home Affairs Notification No. S.O. 1726 dated the 22nd July, 1961, the Lt. Governor of the National Capital Territory of Delhi, hereby makes the following rules further to amend the Delhi Province Stamp Rules 1934 namely:

- 1. Short title and commencement:-(1) These rules may be called the Delhi Province Stamp (Amendment) Rules, 2005.
 - (2) They shall come into force from the date of the publication of this notification in the Delhi Gazette.
- 2. Amendment of rule 1.— In the Delhi Province Stamp Rules, 1934 (hereinafter referred to as "the Principal Rules"), in rule 1 in clause (h), after the words 'Government servant' and before the words "to sell", the words "or Government department" shall be inserted.
- 3. Amendment of rule 26.—In the Principal Rules, in rule 26, in sub-rule (i). for clause (a), the following clause shall be substituted, namely:-
- "(a) that no person / vendor may be licensed to sell any single stamp exceeding the value thereof as fixed by the Chief Controlling Revenue Authority by orders issued from time to time, in this regard".
- 4. Amendment of rule 27.— In the Principal Rules, in rule 27 in sub-rule (i) for clause (1), the following clause shall be substituted, namely:-

- "(1) the person or Government department licensed".
- 5. Amendment of rule 28.—In the Principal Rules, in rule 28.—
- (a) for clause (ix), the following clause shall be substituted, namely:"(ix). The vendor shall not sell any stamp exceeding the value thereof as fixed by the Chief Controlling Revenue Authority.";
- (b) in clause (x), for the words and figures "Rs.500/-" occurring after the word "exceeding" and before the word "required", the words "the limit as fixed by the Chief Controlling Revenue Authority by orders issued from time to time in this regard", shall be substituted.;
- (c) in clause (xi), in sub-clause (d), for the word and figures "Rs. 500/-" occurring after the word "exceeding" and before the words "by the", the words "the limit as fixed by the Chief Controlling Revenue Authority, by orders issued from time to time in this regard", shall be substituted.;
- (d) in clause (xxi), for the word and figures "Rs. 500/-" occurring after the words "not exceeding" and before the words "and to", the words "the limit as fixed by the Chief Controlling Revenue Authority by orders issued from time to time in this regard", shall be substituted.
- 6. In the Principle Rules, in rule 33- (a) for the word and figures "Rs.500/-" occurring at the end, the words "the limit as fixed by the Chief Controlling Revenue Authority by orders issued from time to time in this regard" shall be substituted.
- (ii) in clause (b), for the word and figures "Rs.500/-" occurring at the end, the words "the limit as fixed by the Chief Controlling Revenue Authority, by orders issued from time to time in this regard", shall be substituted.
- 7. In the Principle Rules, in rule 34, in sub-rule (iii), for the schedule under the heading "Rate of Discount", the following schedule shall be substituted, namely:-

	(c) In respect of Bank and government departments, the rate of discount shall be the amount or percentage as agreed by the Government".
